## PART – I

### **1. Introduction**

The Institute of Nursing Education, Bambolim-Goa recognized by the Indian Nursing Council functions as an independent unit under the Directorate of Health Services, Government of Goa. The Institute currently conducts four nursing educational programs:

- a) Auxiliary Nurse Midwifery
- b) Bachelor of Science in Nursing
- c) Post-Basic Diploma: i) Cardiothoracic Nursing ii) Neonatal Nursing
- d) Master of Science (Nursing).

### **2. Philosophy**

We at the Institute of Nursing Education believe that:

- \* The core of nursing is directed towards caring for the individual/family and community (sick or well), therefore the nursing education programs run at the Institute of Nursing Education primarily focus on meeting the health needs of the individual/family/community.
- \* Efficiency in the teaching-learning process is enhanced by teachers regularly updating their knowledge through in-service-education programs and other educational forums.
- \* Students should be prepared to take up leadership positions in nursing and health care fields and function as nurse specialists, practitioners, educators, administrators, change agents and researchers in a wide variety of professional settings in meeting the national priorities and the changing health needs of the society.

### **3. Objectives:**

On completion of the program, the postgraduate nurses will:

- a) Utilize/apply the concepts, theories and principles of nursing science.
- b) Demonstrate advance competence in the practice of nursing.
- c) Practice as nurse specialists.
- d) Demonstrate leadership qualities and function effectively as nurse educators and managers.
- e) Demonstrate skill in conducting nursing research, interpreting and utilizing the findings from health related research for evidence based nursing care.
- f) Demonstrate the ability to plan and effect change in nursing practice and in the health care delivery system.
- g) Establish collaborative relationship with members of other disciplines.
- h) Demonstrate interest in continued learning for personnel and professional advancement.

- 4. Ordinance and scheme of hours:** The M.Sc. Nursing Program shall be governed by the Ordinance OC-59 laid down by the Goa University.

b) In addition to the above the students will be required to pay the following fees:

i) **All the logistics and financial management has to be borne by the students during external posting within and outside the state.**

ii) Examination fee as prescribed by the Goa University

iii) Annual Goa University Sports Affiliation fee Rs. 250/-

**All fees are subject to change**

## **8. Bond**

- a) Government employees will execute a bond as per rules in force.
- b) Non-government employees will execute a bond that they will pay a penalty of an amount which will be decided by the government, if they discontinue the program.
- c) At the time to the admission to the M.Sc. Nursing program, a bank guarantee for the amount of Rs. 1,00, 000/- to be submitted to the Institute of Nursing Education.

**Failure to complete the course or complete the bond service, or on default, such guarantee shall be forfeited to the Government of Goa without any further notice.**

## **9. Affidavit**

On admission every student will submit an affidavit stating that he/she will be attending the M.Sc. Nursing program at the Institute of Nursing Education regularly, and is not working in any institution/organization during their study period.

## **10. Anti-ragging**

- a) RAGGING IS STRICTLY PROHIBITED.
- b) AS PER THE GOA PROHIBITION OF RAGGING ACT, 2008, (THE GOA ACT 9 OF 2009) AND THE GOA PROHIBITION OF RAGGING (AMENDMENT) ACT 2010 (THE GOA ACT 17 OF 2010) ANY STUDENT/STUDENTS WHO IS/ARE FOUND GUILTY OF RAGGING AND /OR ABETTING RAGGING IS/ARE LIABLE FOR PUNISHMENT.
- c) On admission, every student shall register an affidavit online affirming to the effect that he/she has not been expelled and/or debarred by any institution for any act of ragging and further that he/she will not indulge actively or passively, in the act or abet the act of ragging and if found guilty of ragging and/or abetting ragging will be liable for punishment. A copy of anti-ragging affidavit shall be submitted within 30 days of admission.

#### **d) Punishment for ragging**

- i) Whoever directly or indirectly, commits, participates in, abets or propagates, ragging, within or outside the Institute shall, on conviction, be dealt with by the Principal of the Institute and resorted to disciplinary action.
- ii) If the individuals committing or abetting ragging are not identified, collective punishment will be resorted as a deterrent punishment and to ensure collective pressure on the potential raggers.
- iii) Any student so convicted shall further be removed from the roll of the Institute and such students shall not be admitted in any other educational institution in the state of Goa for a period of three years from the date of such conviction.
- iv) The punishment may also take the shape of:
  - Debarring from representation in events,
  - Withholding results, and/or
  - Suspension or expulsion from Institute.
- v) The migration certificate shall include an entry of whether the student had indulged in ragging and in particular was punished for ragging, apart from the student's general conduct and behaviour.

#### **11. Miscellaneous**

- a) Students shall have two sets of separate uniforms for hospital and for community practical experience.
- b) Students shall follow rules in respect to the use of the Institute's library, laboratory facilities and hostel facilities.
- c) Students shall follow the rules and regulations of the Institute where they gain their practical experience.
- d) Students shall actively participate at the local, state and national level activities conducted by the Trained Nurses Association of India, professional bodies and Continuing Nursing Education Cell of the Institute.
- e) Students shall have a minimum of 80% attendance in theory and practical in each course, to be eligible to appear for the examination. However a student shall be required to have 100% attendance in each of the practical components which shall be certified by the Institute, before the declaration of results.

## PART- II

### 1. Eligibility for admission:

- a) A candidate to be admitted for the M.Sc. Nursing Program should
  - i) Be a citizen of India.
  - ii) Have passed the B.Sc. Nursing/Post Basic B.Sc. Nursing Program from a Nursing Institution recognized by the Indian Nursing Council, with a minimum of 55% aggregate marks.
  - iii) Be a Registered Nurse and Registered Midwife or equivalent.
  - iv) Have a minimum of one-year work experience in rendering nursing care services in hospital /community area after completion of the B.Sc. Nursing program OR one – year prior to or after Post Basic B.Sc. Nursing program.
  - v) Have completed the bond services/paid the bond amount as prescribed by the Government of Goa (applicable for candidates who have obtained the basic qualification from government institution).
  - vi) Have resided in Goa for a period of fifteen years.
  - vii) Be medically fit.
  - viii) Be a life member of the Trained Nurses Association of India.
- b) Knowledge of Konkani is essential/Marathi is desirable.
- c) In-service candidates of state/central applying for admission should produce study permission/NOC obtained from the employer. Advanced copy of application submitted by the candidates without study permission/NOC will be accepted. However candidates should submit the same within 15 days of admission.

### 2. Application for admission

- a) The application form appended to the prospectus is available at the office of Institute of Nursing Education, Bambolim on payment of Rs. 1000/- (Rupees One Thousand only) in cash.
- b) The complete application for admission is to be submitted so as to reach the said office on or before the notified date **(1<sup>st</sup> July 2025 by 4.00 p.m.)**. In-service candidates should submit application through proper channel.
- c) The application for admission is to be accompanied by self attested photocopies of the testimonials and certificates as required vide Part II, clause 3 of the prospectus.
- d) **A candidate can apply in more than one category. However the candidate must submit a separate application form along with all the required certificates for each category.**

**3. Testimonials and certificates (self attested) required to be enclosed with the application form**

- a) Certificate of birth from the Registrar, Births and Deaths.
- b) Certificate of passing and statement of marks obtained at S.S.C. and H.S.S.C. issued by the recognized board.
- c) Certificate of passing and statement of marks obtained for B.Sc. Nursing/Post Basic B.Sc. Nursing Program issued by the University.
- d) B.Sc. Nursing /Post Basic B.Sc. Nursing degree issued by the University.
- e) Migration certificate issued by the university (for Candidates who had passed B.Sc. Nursing/Post Basic B.Sc. Nursing Program from a University other than Goa University)
- f) Agreement cum bond completion certificate/proof of payment if bond period is not completed from the head of the institution.
- g) Registration Certificate (including the latest renewal) from the State Nursing Council.
- h) Provisional Eligibility Certificate from Goa University. Candidates who had passed B.Sc. Nursing from a university other than Goa University will not be admitted for the program without the eligibility certificate.
- i) Residence Certificate as per Annexure I of the prospectus from the Mamlatdar of the concerned taluka indicating that the candidate has been residing in the state of Goa for a minimum period of 15 years.
- j) The condition of 15 years residence may be relaxed to 10 years for candidates who have passed the qualifying examination out of the state or who have been employed outside the state.
- k) Medical examination and fitness report from government doctor **ONLY**. In addition, a certificate that the candidate has been immunized against Hepatitis-B must be attached.
- l) Life membership card of TNAI.
- m) Work experience certificate specifying the designation, period of employment, area and nature of work.

**4. Candidates applying under the reserved category shall also enclose:**

- a) A valid non-migrant caste certificate in the prescribed proforma (Annexure II) from the Deputy Collector of Government of Goa for candidates claiming seat reserved for the Schedule Caste/Tribe category. Certificates issued by the Village Panchayat/Mamlatdar shall not be accepted.
- b) A **recent and valid** caste certificate (non-creamy layer and non-migrant) in the prescribed proforma (Annexure III) from the Deputy Collector of the area concerned for candidates claiming seat reserved for OBC category. Certificates issued by Village Panchayat/Mamlatdar shall not be accepted.
- c) A certificate from the constituted Medical Board of GMC Hospital, Hospicio Hospital or Asilo Hospital for a candidate claiming seat reserved for the physically challenged category stating his/her disability and ability/fitness to undergo all parts of the syllabus of the program. The percentage of disability should be recorded on the fitness certificate

Persons suffering from not less than 40% (forty percent) disability shall be eligible for the reserved seat.

- d) Service certificate from the head of the office/department about the current posting of the candidate/spouse/parent, for candidates claiming seat reserved for Goa State/Central Government employees including Goa state/Central Government/Public Sector undertaking and defense personnel. The service certificate should indicate the full name of the candidate/spouse/parent, designation date of transfer order, place transferred from, date of joining and present status of posting for candidates applying under CSP category.
- e) Income & Assets certificate in the prescribed proforma (Annexure IV) from the Mamlatdar of the concerned Taluka should be produced by candidates applying under the EWS Category

## **5. Photograph**

### **The candidate must**

- a) Affix a recent passport size photograph on the application form. The photograph has to be self attested (ensure that the signature is on the application form and the photograph).
- b) Submit an additional copy of the photograph with their names written in pencil on the reverse of the photograph.

## **6. Special instructions**

- a) Applications which are incomplete or submitted after the due date and time will not be considered.
- b) All certificates enclosed with the application form should be self-attested.
- c) Copies of self attested certificates attached with the application form will not be returned even if the candidate is not selected.
- d) No original certificates should be attached to the application form.
- e) The candidate will have to produce certificates in original for verification at the time of admission.
- f) If for any genuine reason, a candidate is unable to submit the required certificates, the candidate shall be provisionally admitted. However, she/he must provide an undertaking that all certificates shall be submitted within a period of 8 (eight) days from the date of admission. Failure to do so will result in cancellation of admission. **No candidate (qualified from universities other than Goa University) can be admitted without the eligibility certificate from the Goa University.**

### 8. Allocation of seats and Specialties offered

**Specialties offered:** Medical Surgical Nursing, Obstetrical and Gynecological Nursing, Community Health Nursing, Paediatric Nursing, Mental Health Nursing.

**Seats in each speciality will be allocated according to the merit at the entrance examination and availability of the specialty faculty**

### 9. Guidelines for selection

- a) Candidates shall be provisionally selected in the order of merit in the entrance examination which will be held on a date and time specified.
- b) The entrance examination shall be based on the B.Sc. Nursing syllabus, Logical Reasoning, English (Language, Comprehension), and General Knowledge.
- c) If candidates have equal scores in the entrance examination, the candidate having a higher score in the qualifying examination will be selected.
- d) If candidates have equal scores in the entrance examination and qualifying examination, the candidate having maximum work experience will be selected.

### 10. Notification of eligible, selected and waitlisted candidates

The eligible list of candidates will be displayed on notice board on **3<sup>rd</sup> July 2025 at 10 a.m.**

Candidates are expected to bring to the notice of the Principal (in writing) any discrepancy on the eligibility list within 24 hours of display, failing which the candidate himself/herself shall be responsible for the consequence of such an error. The candidate should also ensure that the revised position if any is informed to him/her.

The names of the candidates who are provisionally selected and are in the waiting list will be displayed separately on the notice board of the Institute of Nursing Education, Bambolim Goa on **10<sup>th</sup> July, 2025 at 10 am.**

**If any seats remain vacant after the admission process, vacant seats will be filled by prospectus and admission committee following the admission process within one month of commencement of programme.**

The provisionally selected candidates should report to the Institute of Nursing Education on the date and time as notified on the selection list along with the fees and their original certificates for verification. Fees are to be paid **by Demand Draft drawn in favor of, Principal, Institute of Nursing Education, Bambolim, Goa.**

The list of waitlisted candidates will be displayed as per availability of seats.

## 11. Cancellation of admission

If any candidate who is offered admission does not report or pay the prescribed fees within the date specified in the notice of admission, the offer will be treated as cancelled and seat will be offered to the next eligible waitlisted candidate. Candidates unable to report for genuine reasons, should intimate the office Institute of Nursing Education by mail principal-ine.goa@nic.in or in writing on the same day. However they are expected to report on the next day by 12 noon, failing which the admission offer will be cancelled.

## 12. Cancellation of admission by admitting authority

- a) If a candidate has paid the admission fees but fails to report to the Institute as per the date given in the selection list he/she shall forfeit the claim for admission and the admission fee shall be forfeited.
- b) If any information/certificate submitted by the candidate in connection with his/her admission is found to be incorrect at any time in the future, his/her admission shall be cancelled forthwith and the entire fees shall be forfeited.
- c) Admission offered to the candidates shall be cancelled, at any time if the Goa University declares that the candidate is not eligible for admission. In this case, the entire fees except admission fees will be refunded.

## 13. Cancellation of admission by the candidate and refund of fees

- a) Admission fee shall not be refunded under any circumstances on cancellation of admission.
- b) A cancellation fee of Rs. 1000/- (Rupees One Thousand Only) shall be levied for cancellations before commencement of academic term (as notified by Goa University) and cancellation fee of Rs. 2000/- (Rupees Two Thousand Only) shall be levied for cancellations within 30 days (**September 1<sup>st</sup>, 2025 before 12 noon**) from the commencement of academic term.
- c) There shall be no refund of fees for cancellation after the last notified date of admission (**September 1<sup>st</sup>, 2025**) for the program. **In addition the candidate will have to pay a penalty as decided by the government, as stipulated in clause 8 of Part-I.**
- d) Fees shall be refunded on submission of an application from the candidate requesting for cancellation of admission and only on production of the original fee receipt.
- e) **Mode of payment will be through ECS credited to the candidate's bank account.**

## 14. Any change which come into effect after the prospectus is printed shall be displayed on the notice board of Institute of Nursing Education, Bambolim, Goa.


